The Radnor Township Board of Trustees met on Monday, March 27, 2023 at 6:30 PM at the Radnor Community Center.

Trustee Watkins called the meeting to order and Trustee Boysel led the Pledge of Allegiance.

Roll Call was taken as follows: Teresa Watkins, aye; Dave Weber, aye; Dan Boysel, aye. Also present, Jenifer Way-Young from the Delaware Public Health District, Joe Clase from Plan4Land with his wife, Bob Fish, Steve Belville, and Katarina Wheeland.

Trustee Boysel motioned to approve the March 13, 2023 meeting minutes; Trustee Weber seconded. All ayes, motion carries 2-0.

Jenifer Way-Young from the Delaware Public Health District distributed fliers to the Board regarding the DPHD's waste disposal dates, norovirus prevention, and clinic schedule. Trustee Watkins notified Ms. Way-Young about a complaint the Township received from a resident requesting the Health Department check a house on Warrensburg Road; Jenifer said she could forward the information to the correct contact.

Bob Fish requested the Board approve the hire of three new employees for the Fire Department; Trustee Boysel motioned to approve hiring the three fire fighters, Trustee Weber seconded; all ayes, motion carries 3-0. Additionally, Bob asked the Board to approve the purchase of a new boat motor. Initially, Bob was looking at a used motor for less than \$5,000.00, however the Board suggested purchasing a new motor for the boat. Trustee Weber motioned to approve the purchase of a new boat motor no matter the cost, Trustee Boysel seconded; all ayes, motion carries 3-0.

Joe Clase, owner of Plan4Land, attended the meeting at the request of the Board to provide more information regarding his services and how his business may be useful to the Township in getting grants for park improvements. Trustee Boysel motioned to put Mr. Clase on retainer for \$300.00 a month, Trustee Weber seconded; all ayes, motion carries 3-0. The Board will set up a meeting with Mr. Clase to create a park plan and strategic plan in order to initiate the search for which grants the Township would most benefit from.

Trustee Weber stated he spoke with a resident on River Road regarding a broken culvert/tile. The resident, Mr. Rhodes, is willing to repair as he has the equipment and will already be working in the vicinity. Trustee Boysel motioned to utilize Mr. Rhodes as a contractor for the work, assuming he provides the Township with his insurance information, Trustee Weber seconded; all ayes, motion carries 3-0.

Trustee Watkins provided the Board with two quotes for the Township Park baseball fields that were obtained by Rich Lantham of the Radnor Youth Athletic Association. The quote to repair the broken fence along the back of the smaller ball field is \$3,6732.99 and the quote for turf repair to both fields is \$1,942.00. Trustee Weber motioned to approve both quotes and proceed with the proposed work, Trustee Boysel seconded; all ayes, motion carries 3-0.

The Board was presented with the Payment Listing and the Fund Status as of March 27, 2023. Trustee Boysel motioned to approve the Payment Register for March 14-27 2023, Trustee Weber seconded; all ayes, motion carries 3-0.

There being no further business, Trustee Weber moved to adjourn and Trustee Boysel seconded; all ayes, motion carries 3-0. The next regularly scheduled Board of Trustees meeting will be held on Monday, April 10, 2023 at 6:30 PM.
