The Radnor Township Board of Trustees met on Monday, October 23, 2023 at 6:30 PM at the Radnor Community Center.

Trustee Watkins called the meeting to order and Trustee Weber led the Pledge of Allegiance.

Roll Call was taken as follows: Teresa Watkins, aye; Dave Weber, aye; Dan Boysel, aye. Also present, Ann Jones, Ken Fryman, Bill Thompson, Jenifer Way-Young, Joe Clase, Todd Coonfare, and Katarina Wheeland.

Trustee Boysel motioned to approve the October 9, 2023 meeting minutes; Trustee Watkins seconded. All ayes, motion carries 2-0.

Representatives from Radnor Heritage Museum updated the Board on museum renovations. Ann Jones alerted the Board that Devon Hartwick backed out of the window and ceiling project, and will be refunding the Township money already paid to him for the work not completed.

Bill Thompson requested the Township support now allowing solar farms in the area.

Jenifer Way-Young distributed fliers from Delaware Public Health Department regarding their vaccine clinic and string light drop off.

Todd reported the concession stand at the Township park was winterized by J & J Plumbing, who also fixed a leak at the historical museum. Todd stated the F350 truck bed is shot and suggested putting a flat bed on the truck.

The Board tabled the discussion to install a heater for the salt barn until next meeting.

Joe Clase, with Plan4Land, discussed the strategic plan meeting and provided the Board a draft of his plan. He will be back at the end of November with a final plan summary.

Trustee Weber updated the Board on the salt barn building, stating concrete was poured and electric will be going in.

Trustee Watkins notified the Board she is receiving bids to remove the shingles at the Curtis Rd. property and suggested they appoint another Trustee as the lead person beginning January 1, 2024; Trustee Weber motioned to appoint the new township trustee; Trustee Boysel seconded. Trustee Watkins also stated she is looking for quotes for repairing the concession stand and shed at the Township park.

The Radnor Township Fire Department provided no report to the Board.

The Board was presented with Payment Listing for October 10 to October 23, 2023; Trustee Weber motioned to accept the Payment Register for October 10-23, 2023 and Trustee Boysel seconded; all ayes, motion carries 3-0.

The Board passed Resolution #09-23, updating the certified amounts for 2023; Trustee Weber motioned to accept Resolution #09-23, Trustee Boysel seconded; all ayes, motion carries 3-0.

There being no further business, Trustee Weber moved to adjourn and Trustee Boysel seconded; all ayes, motion carries 3-0. The next regularly scheduled Board of Trustees meeting will be held on Monday, November 13, 2023 at 6:30 PM.
