The Radnor Township Board of Trustees met on Monday, August 12, 2024 at 6:30 PM at the Radnor Community Center.

Trustee Boysel called the meeting to order and led the Pledge of Allegiance.

Roll Call was taken as follows: Dan Boysel, aye, Dave Weber, aye, Cameron James, absent. Also present: RTFD employees Bob Fish and Shawn Kelly, Jenifer Way-Young from Delaware Public Health District (DPHD), and George Weisner and John Turner from Radnor Youth Athletic Association (RYAA).

Trustee Boysel motioned to approve the July 22, 2024 meeting; Trustee Weber seconded. All ayes, motion carries 2-0.

Open Discussion:

Jenifer Way-Young, DPHD, reported the river sweep will take place on October 12, 2024 where Boy Scouts will hopefully assist.

George Weisner announced Jonathan Turner as the new president for RYAA; they reported there is excitement for the upcoming season.

Fire Department Report:

Chief Fish reported the new uniforms for the new hire and existing department members are on order and will cost just under eight thousand dollars. He also reported new boots are going to cost approximately \$2,370.00. Regarding the nine new hires, orientations are taking place.

Fire Hose testing was completed last week; suggestions were made to donate out of use fire hoses to the Columbus Zoo. *began*

Ben Moder completed EMT training class, which the Township paid for.

Asst. Chief Kelly provided the Board with a quote for an automatic standby generator for the fire station from Winig's Company in Marion; he reported there are two options: whole house automatic transfer switch that would allow the entire facility to operate at a cost of \$52,534.00 or a smaller unit to run essentials for \$32,755.00. No action will be taken at this time.

The Fire Department presented discussion about replacing the sign for the fire department and community room with a marquee sign; options and cost will be looked into more intently in the future. They also discussed current cost of wifi/internet services; Current costs and upgrades are being evaluated.

Chief Fish reported Engine 431 has been picked up from the service center at Rosenbauer; however, it remains out of service due to faulty performance.

Final inspection was made on the fire station fire alarm and we passed the inspection; Genesis will be doing a training on the fire alarm systems functions.

Trustees Report:

Trustee Weber suggested the Maintenance Building, located at 4156 Radnor Road, have its own refuge dumpster; Trustee Boysel agreed. Trustee Weber will get a cost and make arrangements to have Rumpke deliver a dumpster.

Sept. 23rd

Trustee Weber reported that following the August 26th meeting, he would be assessing the township road conditions with Doug Riedel from the Delaware County Engineer's Office.

Trustee Boysel reported a vote was made for the OPWC Committee Board for their new board member.



Trustee Boysel stated he is still awaiting a response from Dave Riepenhoff for a public records question.


Trustee Boysel will be getting assistance from the county zoning and health department to investigate a nuisance trash complaint brought to the Board for a residence located at 4184 John Street.




