The Radnor Township Board of Trustees met on Monday, October 14, 2024 at 6:30 PM at the Radnor Community Center.

Trustee Boysel called the meeting to order and led the Pledge of Allegiance.

Roll Call was taken as follows: Dan Boysel, aye, Dave Weber, aye, Cameron James, aye. Also present: RTFD employees Bob Fish, Shawn Kelly, Dorian Ross, Brad Belville, Greg Butts and Steve Belville, Joe Thrush, Jim Hill, and Katarina Wheeland.

Trustee Boysel motioned to approve the September 23, 2024 meeting; Trustee Weber seconded. All ayes, motion carries 3-0.

Fire Department Report:

The Fire Department plans to start soliciting for bids for Engine 431 and plans to ask Delaware County Prosecutor's office for advice on selling on third party sites and the bid process. The new truck the department is looking at purchasing will be in Ohio on the first of November.

All new-hires aside from one have begun the orientation process. One hundred percent of available shifts in the past month were fully covered. New EMS bags have been purchased and stocked for all department vehicles.

Spectrum representative Jim Hill provided the Board plans available to the township for internet, phones and cable. Trustee James motioned to go with the 5 year fiber option quoted at \$861.95 a month, Trustee Weber seconded; all ayes, motion carries 3-0.

Community Report:

Joe Thrush reported the 2024 fall baseball season is nearly over and Radnor is hosting the Coach Pitch Tournament. He asked if anything has been done at the fields regarding the recent vandalism; the Board reported the Delaware County Sheriff's office is aware of the ongoing problem and has been patrolling the area more.

Trustees Report:

Trustee James mentioned the carpet in the community room needs cleaned; he will reach out to a few companies to see who can do it before the November election.

Trustee Weber stated water in the maintenance building has been installed by J & J Plumbing. Additionally, Wells Plumbing was at the fire department/community room to repair the toilets.



Fiscal Officer Report:



The Board signed the September 2024 Bank Reconciliation.




