The Radnor Township Board of Trustees met on Monday, September 23, 2024 at 8:00 AM at the Radnor Community Center.

Trustee Boysel called the meeting to order and led the Pledge of Allegiance.

Roll Call was taken as follows: Dan Boysel, aye, Dave Weber, aye, Cameron James, aye. Also present: RTFD employees Bob Fish, Shawn Kelly, Dorian Ross, Brad Belville, and Dylan Blythe, Doug Riedel from the Delaware County Engineer's Office, Todd Coonfare, and Katarina Wheeland.

Trustee Weber motioned to approve the September 9, 2024 meeting; Trustee Boysel seconded. All ayes, motion carries 3-0.

Fire Department Report:

The Fire Department recently donated old fire hoses to the Columbus Zoo; for which, the zoo is planning a media event around. Engine 431 business: Chief Fish, Trustee Boysel and County Prosecutor's office representative Michael Cavanaugh are working together to formulate a sale price for the engine and an "as-is" contract for the buyer. Chief Fish notified the Board that all trucks recently passed pump testing.

Community Report:

Doug Riedel provided the Board with OPWC paperwork for 2025; the Board signed Resolution #09-24 assigning Trustee Weber as representative for the Township and agreeing to the joint OPWC project with Troy Township and Delaware County; Trustee Boysel motioned to approve Resolution #09-24, Trustee James seconded; all ayes, motion carries 3-0.

Maintenance Report:

Todd state tree trimming in the cemetery and around the maintenance building is complete. The maintenance department is currently working on cemetery foundations and the department is down to two employees, himself and Dennis Watkins.

Trustees Report:

Trustee James reported the noxious weed issue on N. Sectionline Rd has been remedied after speaking to the land owner who plans to put the property on a mowing schedule.

Trustee Weber obtained a generalized quote from Smalls Asphalting for road maintenance and upkeep to have a general idea of funds needed once the Road Levy expires; he was quoted \$23,000 per mile of 16ft wide road.

The Board set Trick-or-Treat for Thursday, October 31, 2024 from 5:30 PM to 7:30 PM for Radnor Township.

Trustee Boysel addressed the Curtis Road project; the Board was presented with, and signed, Resolution #10-24, Addendum to Construction contract. Trustee Weber motioned to accept Resolution #10-24, Trustee James seconded; all ayes, motion carries 3-0.



Fiscal Officer Report:




