Call to Order and Roll Call

The Radnor Township Board of Trustees met in regular session on Monday, August 11, 2025, at 6:30 PM at the Radnor Township Community Center, 4061 State Route 203, Radnor, Ohio. Chairperson Boysel called the meeting to order, and the roll was called; attending were Trustees Dan Boysel, Cameron James, and Dave Weber.

Approval of Minutes

Reading of the minutes has been postponed until the August 25 meeting.

Public Input

- Donna Meyer requested information on how to do a public records request and brought attention to grant opportunities for farm markets.

- Roger Plymal, Radnor, spoke on the benefits of attracting a Dollar Tree General Store to Radnor. He also praised the Fire Department.

Fire Department

- Interim Fire Chief Fish reported the Quint was put into service on August 10 and had its first fire run on the 11th. The Scioto Twp engine will be returned by the end of the week. Interviews have begun for 4 of 7 applicants for firefighters.
- Genesys will be doing system maintenance this Friday.

Road/Maintenance Department

- River Road culvert between Dildine and Radnor Road, the township is working with the landowner to
 do repairs at the landowner expense, as an optional solution can be performed on the landowner's
 property to drain the field.
- One the same section of River Road a complaint was fielded regarding the completeness of the repair work. Chip and seal will be placed in next year's budget to complete the maintenance. i
- Evans Steed road repair has been completed.
- Culvert cleaning issue was brought up on Byers Road. It is the Twp responsibility to clean the ditch beside the culvert ends.
- Todd Coonfare reported Tony Fisher will be moving ahead on low hanging tree removal on River Road from St Rt. 37 to Curren Road. It is estimated to be a 4–5-day project with an estimated budget of \$6000-\$9000.
- We have begun berming roads and have used approximately 130 tons of stone on Hoskins, Sectionline, Price and Buttermilk Rds.

Board Report

- Mr. James moved to purchase 2 trash bins and 2 park benches for approximately \$800 to be used in the cemetery. Mr. Boysel made a second to the motion. Motion carried 2-1 with Mr. Weber voting nay. It was suggested to place an article in the newsletter requesting sponsorships for items such as this for \$200 per bench or trash receptacle.
- Mr. James updated us on the obnoxious weed concern on Dildine Road, and the landowner is working to resolve the issue.
- Mr. Weber, no report.

- Mr. Boysel reported a noxious weed concern at Sectionline and 203. All trustees reviewed the issue and no action was taken.
- Mr. Boysel undated the Board on the cemetery disinterment.
- Mr. Boysel discussed the Zoning Committee; the next committee meeting will be held on Thursday August 14, 6:30 at the township hall.

 Mr. Weber moved, and Mr. James seconded to approve pending warrants detailed in payment listing detail report for August 1,2025, through August 11, 2025, Vote: Boysel, aye; Weber, aye. James, aye. Motion passed.
