Call to Order and Roll Call

The Radnor Township Board of Trustees met in regular session on Monday, June 23, 2025 at 8:00 AM at the Radnor Township Community Center, 4061 State Route 203, Radnor, Ohio. Chairperson Boysel called the meeting to order and the roll was called; attending were Trustees Dan Boysel, Dave Weber, and Cameron James.

Approval of Minutes

Mr. Boysel moved and Mr. James seconded to approve the minutes of the June 9, 2025 meeting. Vote: Boysel, aye; Weber, aye; James, aye. Motion passed.

Public Input

- Jenifer Way-Young, Delaware Public Health District, distributed fliers for various events including the mobile clinic summer tour schedule, a breastfeeding lunch and learn session, and information regarding ticks, poison hemlock and agricultural tire drop off.

Fire Department

- Chief Fish requested Board approval to advertise that the fire department is hiring; he would like to get the daytime/parttime staffing back up and ideally wants to hire six new employees. The Board agreed.
- There is a worker's comp grant available for small tool purchases; Mr. Fish is looking into the grant.

Road/Maintenance Department

- The berm attachment has been installed and the truck returned; Todd Coonfare is hoping to test soon.
- Mr. Coonfare plans to call Fisher Tree Service regarding overhanging tree limbs on River Road to prepare for school buses.

Board Report

- Mr. James discussed the proposed park drawing prepared by Plan 4 Land; Mr. James moved and Mr. Boysel seconded to approve the scope of project and proceed with advertising for bid requests. Vote: Boysel, aye; Weber, aye; James, aye. Motion passed. The bid packet will need to be advertised by June 30, 2025. The park committee plans to meet on August 7, 2025 to look over bids and the Board can approve bid at August 11, 2025 meeting.
- Mr. Weber contacted ODA regarding illegal ~~dumping~~ ^{lawn + playground application} of chemicals at the township park; he just notified ODA and did not want to file charges. Mr. Weber also spoke to the individual with a warning.
- Mr. Boysel discussed renewing/replacing the Road Levy that is expiring this year; he plans to discuss options with the county auditor in order to move forward with placing a levy on the November ballot.

Financials/Fiscal Officer

- Mr. Boysel moved and Mr. Weber seconded to approve pending warrants detailed in payment listing detail report for June 10, 2025 through June 30, 2025. Vote: Boysel, aye; Weber, aye; James, aye. Motion passed.




Adjournment
