Call to Order and Roll Call

Fire Department

- Rescue equipment has been ordered.

- Schilling replaced the original propane tank due to a leak.

- Touch-a-Truck was held at Buckeye Valley High School and the department brought the new ladder truck.

Road/Maintenance Department

- 52 tires were taken to the county dump; more tires are being dumped in various spots, most along River Rd.
- The berm box was fitted on the Freightliner at Dexter's.
- Mr. Coonfare reported there is a family burial at the cemetery where a baby was buried in 1948; a family member is requesting the Township dig up the baby so he can be buried in the spot; the Board agreed with Todd that the family will need to obtain a court order to dig up a burial spot before any action is taken.
