The Radnor Township Board of Trustees met on Monday, February 26, 2024 at 6:30 PM at the Radnor Community Center.

Trustee Boysel called the meeting to order and Trustee Weber led the Pledge of Allegiance.

Roll Call was taken as follows: Dan Boysel, aye, Dave Weber, aye, Cameron James, aye. Also present, Joe Thrush, RTFD employees Josh Loney, Macey Stevens, Jordan Long, Ben Moder, Greg Butts and Steve Belville, Todd Coonfare, and Katarina Wheeland.

Trustee Weber motioned to approve the February 5, 2023 meeting minutes; Trustee James seconded. All ayes, motion carries 3-0.

Joe Thrush updated the Board on the Radnor Youth Athletic Association 2024 upcoming baseball season. The Board requested a copy for the baseball association's insurance information; Trustee Weber will contact the baseball association's president for verification.

Maintenance Department Report:

Todd Coonfare provided the Board with an update stating he needs to purchase pins for new cemetery plotting and purchase trash containers for the township park. The department has been trimming trees over roads and cold patching pot holes.

Fire Department Report:

Engine 431 is down again; it is at All American and the fire department plans on keeping the truck there until it is fully functional as it will be out of warranty in April. Engine 431 left the fire house with 5,957.3 miles on it and 301 hours of use; Trustee Boysel plans to discuss the situation with the Delaware County Prosecutor's Office.

Firefighter Brad Belville is having issues with the Curtis Road property the department plans to use for a fire burn training; he needs paperwork from Asst. Chief Fish in order to submit reports to obtain permits; Trustee Boysel stated that Alex McCarthy from FEMA is procuring the permits needed.

Board Report:

Trustee James provided the Board with two bids from monitoring companies: Silco's Bid is \$15,657.52 and Genesis' bid is \$10,755.00 (and will use the same system we currently have); Trustee Weber motioned to accept the Genesis bid, Trustee James seconded, all ayes, motion carries 3-0.

The Board discussed mulch at the township playground; Trustee Weber stated he spoke to Price Farms and they offered to pay for half of all fees.

The Board discussed details for selling the old Chevy truck; Todd will move the truck near the road, we will place ad in newspaper requesting bids by a specific date. Dave will obtain all the information needed for the ad and Katarina will place the ad.

Trustee Weber stated Radnor Township was granted the OPWC grant for Buttermilk Road with Troy Township.

Trustee Boysel motioned to give the Township website administrator a raise to \$250/quarter, Trustee James seconded, all ayes, motion carries 3-0.

Trustee Boysel dispersed information regarding Resolution #03-24, amending local government and revenue assistance fund distribution; Trustee Weber motion to support the Resolution, Trustee James seconded, all ayes, motion carries 3-0.


Trustee Boysel updated the Board on the investigation into the Fire Department; stating the investigating attorney plans to have a summary to the Board by the March 11, 2024 meeting.

The Board discussed switching the community room rental duties to the responsibility of the township fiscal officer; providing the fiscal officer with a designated township phone and no longer paying a fee per booking. Trustee James motioned to approve, Trustee Weber seconded, all ayes, motion carries 3-0.


Fiscal Officer Report:
